Abstract:

The Grand Army of the Republic (GAR) was a veteran's organization formed in 1866. Membership consisted of honorably discharged Union soldiers, sailors and marines of the Civil War. This collection contains the biographical and military information on the members, business correspondence, and national and department encampments for the Captain Thomas Espy Post 153, Department of Pennsylvania. The manuscript page on the website contains digitized data from completed membership applications, transfer cards, war sketches and the adjutant's report of deaths.

History:

Captain Thomas Espy Post #153 of the Grand Army of the Republic was chartered in December, 1879. In 1906 the Post entered into an agreement with the newly built Andrew Carnegie Free Library and

Music Hall in Carnegie, Pennsylvania to occupy a permanent room in the Library. The Post furnished and moved into the room in March 1906. Because of this permanent meeting space, the Post was able to keep all of its books and records in one location. They were also able to collect artifacts and relics from the Civil War. Because this room and all of the contents became the property of the Library upon the death of the last member of the Post, the Captain Thomas Espy Post has become one of the most intact examples of a GAR Post in the country.

Collection Scope and Content Note:

This collection contains the late 19th and early 20th century papers of the Captain Thomas Espy Post #153 of the Grand Army of the Republic. Documents include membership applications, transfer cards, war sketch questionnaires, meeting minutes and cash ledgers, personal and official correspondence, financial records, General Orders, information regarding national and department encampments, entertainment programs, a collection of blank forms, ephemera, including two photographs, and ribbon remnants and uniform pieces.
